## Have Your Say!

The Boundary Commission is conducting an electoral review, and this review will recommend new electoral arrangements for Somerset Council. From this review, the Boundary Commission will propose:

- the total number of councillors elected to the council in the future,
- the number of divisions,
- the number of councillors representing each division,
- · division boundaries, and
- the names of divisions.

The Boundary Commission is recommending that 96 councillors should be elected to Somerset Council which is 14 fewer than the current number. In drawing up new electoral divisions, they must balance three legal criteria, namely:

 to deliver electoral equality where each councillor represents roughly the same number of electors as others across the county,

- that the pattern of divisions should, as far as possible, reflect the interests and identities of local communities,
- that the electoral arrangements should provide for effective and convenient local government.

This public consultation welcomes views from individuals and organisations. The consultation is open now and will close on 20<sup>th</sup> January 2025. The new electoral arrangements will come into effect at the local elections in 2027.

If you are a witness to or the victim of a crime, then it is <u>imperative</u> that you report it to the police immediately whether it is during the day or at night. When reporting an incident please telephone either 101 for non-emergencies or 999 for emergencies only.

Parish Council meetings are held in the **Pavilion** on the third Wednesday of every month with the exception of August and December. The next meeting will be on **Wednesday**, **15**<sup>th</sup> **January 2025 at 7pm.** Parish Council meetings are open to the press and public, so residents are welcome to come along and listen to what we have to say. There is also a short public session at the beginning of every Ordinary Parish Council meeting.
