Borough Car Park

Residents have recently expressed their concerns to the Parish Council about the number of vans and other large vehicles that are parking in the Borough Car Park, and some have suggested that permit parking needs to be introduced for the car park.

The Parish Council lease the car park from the National Trust and under the terms of the lease, the car park is for free parking for only cars, motor bikes and bicycles for members of the public.

Recreation Ground Entrance

There have recently been a couple of accidents next to the recreation ground entrance in Bishopston. This first, was inside the recreation ground which resulted in the internal wall being knocked down. After consulting with the National Trust, it was agreed that the damaged wall will be replaced with a gate so as to make the recreation ground more inclusive for wheelchair users.

The second accident happened when a vehicle swerved to avoid a cat and hit the highway barrier by the entrance. The barrier had to be removed as it was obstructing the footpath and, as it is now a safety issue, the Parish Council have asked Somerset Council to get this replaced as quickly as possible.

Crime and Anti-Social Behaviour

If you are a witness to or the victim of a crime, then it is imperative that you report it to the police immediately whether it is during the day or at night. When reporting an incident please telephone either 101 for non-emergencies or 999 for emergencies only.

The next meeting will be on **Wednesday 17**th **July 2024 at 7pm.** Parish Council meetings are open to the press and public, so residents are welcome to come along and listen to what we have to say.
