## **Recreation Ground and Pavilion Update**

Members of the Parish Council recently met with the National Trust to show them around the new pavilion and to discuss the proposed additional improvement work that still needs to be carried out at the recreation ground. This proposed work is to enlarge the car park and provide better fencing/hedging around the car park so that the area is more accessible for those using the facilities. We are also hoping to put a path in from the car park to the pavilion, and to make a small, enclosed area for young children off to the side of the pavilion.

We also discussed the benefits of having improved facilities and its usage, to which the National Trust found favourable. Out of this discussion, it was agreed that the lease would need to be amended so that it could be used out of daylight hours. The National Trust have provisionally agreed to this subject to the approval from their legal team, and in the meantime, they have agreed for the Parish Council to use it up until 10pm.

Parish Council members also asked whether the grounds could once again be used for a bonfire night display. Unfortunately, due to environmental issues, and that the area around the recreation ground is home to thirteen of the country's fifteen species of bats, the National Trust have declined this request.

The Parish Council would like to thank the Bridge Club for their kind donation of £50 towards the pavilion.

When reporting an incident please telephone either 101 for non-emergencies or 999 for emergencies only.
